COLLECTION AND USE OF PERSONAL DATA

- When processing is necessary for the performance of a contract between us or where you request us to take specific steps prior to entering into such a contract, including in particular the processing of information necessary to enable you to use our websites and the services we offer through them.

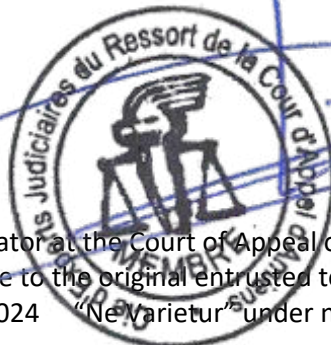
